**Louisiana State Board of Nursing Written Certification to Invoke Executive Order, Proclamation Number 52-JBE-2020, Section 4**

The Louisiana State Board of Nursing (LSBN) hereby invokes Section 4 of Executive Order, Proclamation Number 52-JBE-2020 allowing state agencies, boards and commissions, and local political subdivisions of the state to attend essential governmental meetings via teleconference.

WHEREAS, the Governor declared a public health emergency in Proclamation Number 25 JBE 2020, which was renewed in Proclamation Number 52 JBE 2020 relating to COVID-19;

WHEREAS, a hearing panel of the LSBN was scheduled to conduct disciplinary hearings and to ratify automatic suspensions of licensees and delay/denials of applicants on May 13, 2020.

WHEREAS, all disciplinary hearings were settled or continued; however, the hearing panel is still required to convene to review stipulated disciplinary cases and to ratify staff action.

WHEREAS, the LSBN is unable to conduct said business without the use of a teleconference due to the current public health emergency and stay at home order.

WHEREAS, the LSBN will make all efforts to provide for observation and input by members of the public during the teleconference meeting.
