



LOUISIANA STATE BOARD OF NURSING CONTROLLED SUBSTANCE CONTINUING EDUCATION: APPROVED COURSES

****APRNs previously approved or requesting the addition of Controlled Substances prescribing to their prescriptive authority privileges must provide proof of completion of a board approved 3-hour continuing education course. This is a one-time requirement under current law. Coursework completed prior to January 1, 2018 will not be accepted. The following are approved courses:**
