The following programs reflect a less than 80 percent pass rate for first time test takers:

Dillard University

Jan – December 2024: *15 testers*

11 passed (73.33% passage rate)

Louisiana Christian University

Jan – December 2024: *23 testers*

16 passed (69.57% passage rate)

Southern University at Shreveport

Jan – December 2024: *30 testers*

22 passed (73.33% passage rate)

On January 15, 2025, LSBN staff was notified by LSU Health Sciences Center (LSUHSC) New Orleans with a letter of intent to offer the Traditional Bachelor of Science in Nursing (BSN) program in Baton Rouge, Louisiana, as an Off-Campus Instructional Site (OCIS) of the currently approved LSU Health – New Orleans School of Nursing. Nursing students will be cross enrolled in LSU Health New Orleans and Baton Rouge campuses to access resources at both universities. LSU Health New Orleans intends to implement this off-site campus program by Fall 2025. The OCIS BR program will be run the same as the longstanding LSUHSC School of Nursing program in New Orleans. All processes will be the same including the same admission process, curriculum, resources, administration, student support, and graduation requirements. LSUHSC New Orleans departments, such as the registrar, financial aid, library, information technology, etc., will oversee the OCIS BR students. Since the students will be on the LSU A&M campus, they will also benefit from the LSU A&M resources such as the on-site testing center, writing lab, student success center, etc.

That the Board accept Louisiana Christian University's report and action plan regarding the probationary status of the discontinued Baccalaureate of Science in Nursing education degree program and accept the current status of the new Baccalaureate of Science in Nursing program.

Summary/Background

On January 30, 2024, LSBN staff acquired the educational program report statistics provided for Louisiana nursing education degree programs regarding the NCLEX-RN pass rates from January 1, 2023, to December 31, 2023. The program was placed on probation for non-compliance with LAC 46:XLVII.3535.B. Further, the Board instructed Louisiana Christian University to submit interim progress reports to be reviewed at subsequent 2024 LSBN Board meetings.

On February 12, 2025, LSBN staff received the updated report and action plan from Louisiana Christian University's Baccalaureate of Science in Nursing education degree program. The action plan states that the old program completed in July 2024 with the final 3 remaining students graduating. The new program began in the Fall of 2024 with 7 traditional students and 4 Accelerated BSN students. The Spring 2025 class enrolled 5 traditional students and 3 Accelerated BSN students. The first graduating cohort of the new program for the Accelerated BSN track will be in December 2025. The first graduating cohort of the new program for the traditional track will be in May 2026. The new program was granted initial approval on April 13, 2023, and will remain in initial approval status until all students from the first cohort have graduated and taken the NCLEX Exam.

Summary/Background

On February 4, 2025, LSBN staff received notification from William Carey University School of Nursing (WCU SON) proposing the closure of the Preferred Admissions Track. This admissions track has previously been offered to high school students with high GPAs, allowing these students to be accepted and waive the requirement to sit for the Test of Essential Academic Skills (TEAS) test. Recently WCU SON removed the TEAS requirement for admission based on current literature. The current literature and program data do not show a significant relevance between the TEAS test and successful program completion. The WCU SON has determined that the prerequisite grade point average (GPA) is more relevant. The removal of the TEAS requirement for admission will begin in the spring of 2025. Because the WCU SON is removing the TEAS requirement for admission and using the GPA as a determinant for all students, the Preferred Admission Track will no longer be beneficial and will be closed for spring 2025 admissions.

For the fiscal year ending June 30, 2025, the Board will be recognizing the 2nd year of the two-year license renewals received in the fiscal year ended June 30, 2024, using the average percentage of renewals received in the months of October, November, and December of the fiscal years ended June 30, 2016, 2017, and 2018. The amounts recognized in October 2024 was \$528,500 in RN renewals and \$98,200 in APRN renewals, the amounts recognized in November 2024 was \$729,300 in RN renewals and \$119,900 in APRN renewals, and the amounts recognized in December 2024 was \$2,709,900 in RN renewals and \$368,900 in APRN renewals.
