Dillard University SACSCOC Status Change

On June 24, 2024, LSBN staff received notification from Dillard University that the Southern Association of Colleges and Schools Commission on Colleges (SACSCOC) took action on June 13, 2024 by placing Dillard University on Warning after review of membership at Level III to offer the Master of Science in Nursing because the institution had failed to demonstrate compliance with Core Requirement 11.1 (Library and learning/information resources). SACSCOC accreditation includes all components of the institution – all programs, branch campuses, off-campus sites, and distance learning programs as reported to SACSCOC, thus the Warning status applies to the entire institution. The institutions next review is June 2025 when the SACSCOC Board of Trustees will consider the accreditation status of Dillard University following a review of a Monitoring Report submitted by the institution addressing the standards cited above for non-compliance.

Summary/Background

The results for the three years ended June 20, 2024, 2023, and 2022 are summarized below. The 6/30/24 year-to-date income is higher than the 6/20/23 and 6/30/22 year-to-date income primarily because of increased licensing revenue and interest income. Expenses are generally consistent with the prior two years when compared to the average of the two prior years with exceptions for increases in payroll and related expenses, legal fees, and information technology.

The balance in the money market account is \$3,558,183.75 and the invested cash totals \$12,800,000. At present, the Board has 13 investments maturing in 12 of the next months.

Fiscal Impact

For the fiscal year ending June 30, 2023, the Board recognized the 2nd year of the two-year license renewals received in the fiscal year ended June 30, 2023, using the average percentage of renewals received in the months of October, November and December of the fiscal years ended June 30, 2016, 2017, and 2018. The amounts recognized in October 2023 were \$326,400 in RN renewals and \$54,500 APRN renewals, the amounts recognized in November 2023 were \$450,300 in RN renewals and \$66,500 in APRN renewals, and the amounts recognized in December 2023 were \$1,673,500 in RN renewals and \$204,600 in APRN renewals.

These revenues were in addition to the first year of the two-year renewals received in October, November, and December 2023 and January 2024.
