**Board Approved Continuing Education**

Continuing education contact hours which have been approved either by another Board of Nursing or the American Nurses Credentialing Center (ANCC) are acceptable for re-licensure in Louisiana. Certification by the ANCC in a specialty area of nursing by a certifying body whose requirements have been approved by the LSBN may be used in lieu of contact hours to meet the CE requirements for re-licensure. Academic courses in a post-secondary institution which are related to specific knowledge and/or technical skills required for the practice of nursing or which led to an advanced degree, or to a certification in advanced nursing, may be used in lieu of CE contact hours. Continuing education may also be obtained through one of the LSBN approved providers listed below.
