License suspension stayed and license reinstated with probation to run concurrently with the RNP Agreement executed September 11, 2020, with stipulations. Charge: Unable to practice Safely by Reason of Alcohol or Other Substance Abuse

## Broussard, Holly Ann RN100507 (CO)

License suspended with stay and probated for minimum of two (2) years with stipulations.

Charges: Substandard or Inadequate Care, Other-Diversion of Non-Controlled Substance and Drug Screen Violation
