Changes to Rule §3705: Administration of Anesthetic Agents

Please be advised that the revised version of §3705- Administration of Anesthetic Agents has been added to Chapter 37. Please find the revised version attached and ready to add to the LSBN website. §3705. Administration of Anesthetic Agents

A. Registered nurses, who are not certified registered nurse anesthetists, may administer anesthetic agents to intubated patients in critical care settings, and may titrate and continue infusion of local anesthetic agents through the use of epidural catheters for pain management, excluding obstetric patients, provided that the following conditions are met.

1. There is an institutional policy and plan for registered nurses (non-CRNAs) to administer anesthetic agents to intubated patients in critical care settings, and to titrate and continue infusion of local anesthetic agents through the use of epidural catheters and perineural catheters for pain management for patients other than obstetric patients that includes:

- a. a clear statement of the purpose and goal of the treatment;
- b. written protocols, with documentation of acceptance of the protocols by the medical staff of the agency;
- c. policies and procedures to include but not be limited to the following:
 - i. preparation of solution;
 - ii. initiation of infusion;
 - iii. responding to emergency situations;
 - iv. maximum dose per hour of an anesthetic agent which can be administered by a registered nurse, who is not a certified registered nurse anesthetist, as approved by the medical staff; and
 - v. criteria for documentation of the procedure.

2. No anesthetic agent may be administered by a registered nurse, who is not a certified registered nurse anesthetist pursuant to this part unless there is a medical order by an authorized prescriber. Any orders to change the rate of infusion must be a medical order or in lieu of a specific order to change the rate of infusion, there are clearly stated criteria, by the authorizing prescriber, for adjusting the rate of infusion. However, in an emergency situation, the registered nurse may decrease the rate of infusion before calling the authorized prescriber.

Changes to Rule §3705: Administration of Anesthetic Agents

B. Further, registered nurses, who are not certified registered nurse anesthetists, may titrate and continue infusion of local anesthetic agents through the use of epidural catheters and perineural catheters for pain management, excluding obstetric patients, provided that the following conditions are met.

1. There is documentation that the registered nurse has successfully completed a course of instruction, which includes but is not limited to didactic instruction and supervised clinical practice on the following:

- a. anatomy and physiology of the spinal cord and column and neurological system;
- b. purpose of the epidural and perineural catheter for pain management;
- c. catheter placement and signs and symptoms of misplacement;
- d. effects of medication administered epidurally and perineurally;
- e. untoward reaction to medication and management;
- f. complications; and
- g. nursing care responsibilities:
 - i. observation;
 - ii. procedures;
 - iii. catheter maintenance;
 - iv. proper calibration and operation of infusion pump; and
 - v. removal of the epidural or perineural catheter.

2. Competencies shall be measured initially during orientation and on an annual basis.

C. The administration of anesthetic agents to intubated patients in critical care settings, and the titration and continuance of infusion of local anesthetic agents through the use of epidural and perineural catheters for pain management for patients may not be delegated or assigned by a registered nurse to anyone other than a registered nurse who meets the criteria set forth in this standard.

Louisiana is selected as a Regional Action Coalition State for the Implementation of the Institute of Medicine Report on the *Future of Nursing: Leading Change, Advancing Health*

In October 2010, the Robert Wood Johnson Foundation (RWJF) Initiative on the Future of Nursing at the Institute of Medicine (IOM) issued “*The Future of Nursing: Leading Change, Advancing Health*,” a report setting forth numerous recommendations regarding the future of nursing in the United States. In anticipation of the IOM Report, RWJF and the American Association of Retired Persons (AARP) created *The Future of Nursing: Campaign for Action (CFA)*, a collaboration created by the Robert Wood Johnson Foundation and the AARP Foundation to ensure that all Americans have access to high quality, patient-centered care in which nurses contribute as essential partners in system-wide transformation.

A component of CFA is the calling together of regional action coalitions (RACs), which are convened to advance the *Future of Nursing: Campaign for Action* and are comprised of diverse groups of stakeholders at the state level that can effect long-term sustainable change. RACs will further the overall effort by capturing best practices, determining research needs, tracking lessons and identifying replicable models. RACs are led by at least two co-leads representing nursing and non-nursing organizations who undertake a long-term commitment to manage efforts in a particular region/state. One of the applicants must be an organization dedicated to the promotion of nurses or nursing. The other applicant must be an organization involved in a field outside of nursing. RACs do not receive direct funding from RWJF, rather, RWJF funds technical assistance for RAC work through a grant to the AARP Foundation. In order to ensure RACs are sustainable for the long-term, technical assistance is tailored to meet the specific needs of each RAC and can include access to grantwriters, links to potential funders, and collaboration and coordination with existing RWJF nursing grant programs. Initially, RWJF selected 5 states to serve as pilot RACs (New Jersey, New York, Michigan, Mississippi, and California).

On January 18, 2011, CFA issued an application to all states that would like to be a part of the Wave II expansion plan in which 10 new RACs would be selected. The Louisiana Center for Nursing and AARP Louisiana partnered together to submit an application for Louisiana to become a RAC state. We are proud to say that because of the hard work of organizations like AARP LA, the Louisiana State Board of Nursing – Center for Nursing, the Nursing Supply and Demand Council, the Louisiana State Nurses Association, the Louisiana Organization of Nurse Executives, the Louisiana Hospital Association, Louisiana’s RWJF Executive Nurse Fellows (Warren Hebert, Ann Cary, and Doris Brown), and many supportive nursing and non-nursing organizations that see nurses as essential contributors to advancing health in Louisiana, on February 11, 2011 Louisiana’s application to become a RAC state was accepted by the Campaign for Action Committee.

Now the work begins. It will take all of us working together to *Lead Change and Advance Health* for the citizens of Louisiana. Please stay tuned for upcoming Louisiana RAC meetings and activities. Revised Criteria for Individual Mental Health Treatment Providers

Licenseses and student nurses monitored by the LSBN may require individual treatment by a qualified mental health professional as part of the terms of the agreement or order with the Board. This therapy may be recommended following a comprehensive evaluation or following treatment. The registered nurse or student nurse may or may not be a participant in the Recovering Nurse Program. In accordance with La. R.S. 3419 E. 4. d., *All treatment facilities, treatment plans and referrals must meet criteria approved by the board prior to their use by a nurse.* The Board approved the Revised Criteria for **Individual Treatment Providers** at the March 2nd general Board meeting.

The LSBN is aware that the selection of a qualified mental health professional is constrained by location, insurance coverage or lack thereof, specialty training of the provider and personal preferences. Until now, the Board maintained a list of recognized individual providers which met the *Criteria for Individual Treatment Providers*. The new process allows the licensee or student to review the criteria with the provider of choice. Both the treatment provider and licensee/student will sign a treatment letter agreeing to the recommendations and the terms of the criteria.

The *Revised Criteria for Individual Treatment providers* can be found on the LSBN website. The list of Individual Treatment Providers has been removed. This revised criterion **does not apply to evaluation and treatment centers**. LSBN will still maintain a list of recognized evaluation and treatment centers. Additionally, the RNP/Monitoring Department staff is also available to provide referral sources for certain specialty areas. Declaratory Statement

COSMETIC AND AESTHETIC DERMATOLOGICAL PROCEDURES AND TREATMENTS PERFORMED BY REGISTERED NURSES AND ADVANCED PRACTICE REGISTERED NURSES

Introduction

The purpose of the Louisiana State Board of Nursing is to safeguard life and health of the citizens of Louisiana. Louisiana law (Revised Statutes of 1950, R.S. 37:911 et seq., as re-enacted and amended) delegates responsibility to the Board to establish and publish standards of nursing practice, to regulate the practice of nursing by the registered nurse and the advanced practice registered nurse, to provide for examination and licensure of the nurse practicing as a registered nurse and an advanced practice registered nurse, and to establish standards for educational programs preparing individuals for nursing practice.

The Louisiana State Board of Nursing issues declaratory statements as guidance for licensees committed to providing safe and effective nursing care to the citizens of Louisiana. Declaratory statements do not have the force and effect of law; however, declaratory statements represent the Board's expert opinion relative to specific practice situations which may have widespread nursing application. The safety and welfare of the citizens of Louisiana is given primary consideration in the issuing of a Declaratory Statement.

Declaratory Statement

Cosmetic and Aesthetic Dermatological Procedures And Treatments Performed By Registered Nurses And Advanced Practice Registered Nurses (Cont...)

Accountability and Responsibility of Nurses

Louisiana Nursing Law holds each nurse individually accountable for delivering safe and effective care. The Declaratory Statement is applicable only to nurses who have documented training, knowledge, skills, and the institution or practice setting has a written policy in place. Any nurse who engages in nursing practice where competency has not been achieved, maintained and documented may be subject to disciplinary action.

Declaratory Statement

It is within the scope of practice for a registered nurse (RN) who is appropriately trained and qualified to perform the following cosmetic and aesthetic dermatological procedures and treatments as ordered by a duly licensed prescriber for treatment of dermatologic conditions:

- » Light treatments, such as:
 - » Topical photodynamic therapy (PDT),
 - » Infrared light,
 - » Magenta light,
 - » UVB light,
 - » UVA light;
- » Laser treatments, such as:
 - » Laser skin resurfacing with non-ablative lasers,
 - » Laser hair removal.
- » Injectable treatments (using FDA approved products only), such as:
 - » Sclerotherapy of superficial veins,
 - » Botox (or similar FDA approved products) injections for cosmetic purposes,
 - » **Note: RN scope excludes all dermal fillers (Collagen, Restylane, Juvederm, etc.).**
- » Chemical Peels
 - » Superficial (including: salicylic acid, glycolic acid),
- » Microdermabrasion
- » Medical procedures that are not within the scope of a registered nurse include:
 - » Ablative laser,
 - » Dermal fillers,
 - » Sclerotherapy other than superficial veins,
 - » Hair transplants/implants.

Declaratory Statement

Cosmetic and Aesthetic Dermatological Procedures And Treatments Performed By Registered Nurses And Advanced Practice Registered Nurses (Cont...)

Duly licensed prescribers for purposes of this statement include:

Nurse Practitioners (NP) - It is within the scope of practice for the NP who is duly qualified to provide cosmetic/aesthetic services as a subspecialty provided the NP has a current collaborative practice agreement with a *qualified physician* that has been approved by the Board and provided the clinical practice guidelines delineate the procedures and treatments the NP has the knowledge, skills and abilities to perform. The NP who performs cosmetic/aesthetic procedures must be nationally-certified in specialty area of care with a valid, unencumbered Louisiana license with no disciplinary action pending. Cosmetic/aesthetic procedures may be performed independently within approved clinical practice guidelines as a sub-specialty by nurse practitioners with the exception of the Acute Care NP, the Neonatal NP and the Psychiatric NP, who may perform cosmetic/aesthetic procedures under same conditions delineated for the RN.

Physicians - A qualified physician is one who is trained to perform cosmetic and aesthetic procedures and who is actively engaged in providing aesthetic and cosmetic services in the State of Louisiana. The qualified physician holds a current, unencumbered, unrestricted and valid medical license issued or recognized by the Louisiana State Board of Medical Examiners and is in good standing with no pending disciplinary proceedings, and practices in accordance with rules of the Louisiana State Board of Medical Examiners.

Course of Instruction:

The course of instruction must include both didactic and hands on training. In order to ensure patient safety, the nurse should secure and demonstrate the following knowledge and skills prior to engaging in cosmetic and dermatological procedures:

- A. Anatomy, physiology, pathophysiology regarding the integumentary system as well as systems specific to the procedure(s) being performed.
- B. Proper technique for each dermatologic procedure.
- C. Proper client selection, history taking, physical assessment parameters, indications and contraindications for treatment.
- D. Pharmacology including drug actions/interactions, side effects, contraindications, and untoward effects.
- E. Proper selection, maintenance and utilization of equipment.
- F. Ability to articulate realistic and expected outcomes of the procedure.
- G. Ability to describe potential complications and side effects.

Declaratory Statement

Cosmetic and Aesthetic Dermatological Procedures And Treatments Performed By Registered Nurses And Advanced Practice Registered Nurses (Cont...)

- H. Nursing care required and appropriate nursing interventions in the event of complications or untoward outcomes.
- I. Management of complications or adverse reactions.
- J. Infection control.
- K. Safety precautions.
- L. Documentation appropriate to the type of the procedure being performed.

Practice Setting:

Any registered nurse who is going to engage in medical aesthetic cosmetic or dermatologic procedures should ensure that the following criteria are met prior to participating in those procedures:

- A. Medical aesthetic treatment has been prescribed or ordered by a qualified physician or NP practicing in collaboration with a qualified physician who possesses the specific knowledge, and ability to perform the procedure(s) independently;
 - B. The RN has been appropriately trained and is qualified to perform the prescribed medical aesthetic procedures;
 - C. Medical aesthetic procedures must be preceded by a history, an appropriate physical exam conducted by a qualified physician or NP practicing in collaboration with a qualified physician, a diagnosis which confirms that any treatment recommended is appropriate for the patient's condition, informed consent, availability and instructions for emergency and follow-up care and the preparation of an appropriate medical record. The registered nurse may apply standing orders and protocols for each procedure prescribed.
 - D. All treatments and procedures must be performed in a medical facility or medical office. **The physician or NP must be physically present on the premises and immediately available at all times that the RN is engaged in the provision of patient care covered by this statement.**
 - E. The institution or practice setting maintains written policies and procedures applicable standards of practice, and evidence based practice, which includes, but is not limited to, provision of specific direction on equipment, patient monitoring, and directions for dealing with complications of procedures.
 - F. The institution or practice setting has in place educational/competency validation procedures. In addition, evaluation and documentation of competence occurs on a periodic basis according to institutional policy.
