#### **Celebrate Nurses**

National Nurses Week is May 6 - 12. This is an opportunity to recognize and appreciate nurses for the contributions they make to the health care of the citizens of Louisiana. There are over 41,000 Registered Nurses living and working in Louisiana. The Louisiana State Board of Nursing salutes registered nurses this week and every week of the year.

### Credentialing Issues

#### Licensure Renewals

Louisiana has 46,742 Registered Nurses with 41,211 residing in the State. The total number of Registered Nurses increased by 1219 over the number reported in 2004 and the total number of RNs residing in Louisiana increased by 1231 over 2004. The number of RNs under 30 years of age increased from 5,911 in 2004 to 6,336 in 2005. The number of RNs in the state is expected to continue to climb as enrollments in Louisiana nursing programs have increased for the third consecutive year. The number of Advanced Practice Registered Nurses licensed and residing in Louisiana is 2,291, an increase of 168 over 2004.

#### **Re-licensure Audit**

The Continuing Education Audit for compliance in 2004 is in progress. One thousand two hundred and eight (1,208) RNs were randomly selected and notifications were sent out March 7, 2005. April 7, 2005 was the deadline for responses. As of April 11, 2005, 938 or 78% of the RNs selected have verified compliance.

Licensees who have not satisfactorily met the audit or falsified the licensure renewal application are subject to have their licenses invalidated and disciplinary action imposed.

REMINDER: Continuing Education is mandatory for licensure renewal. RNs employed full time must have 5 contact hours, those employed at least 160 hours/year must have 10 contact hours and those not employed must have 15 contact hours annually for the renewal of their Louisiana license.

#### Recovering Nurse Program (RNP)

**Q.** What is the Recovering Nurse Program?

**A.** The Recovering Nurse Program is a confidential, voluntary alternative to formal disciplinary action for a Registered nurse who may be impaired due to chemical dependency/abuse or a physical/mental condition.

#### Recovering Nurse Program (Cont...)

The Nurse Practice Act (L.R.S. 37:911-933) provides that alternatives to disciplinary action may be established. L.R.S. 37:922 (Sec. E) reads in part: "The Board, in its discretion, may maintain the confidentiality of an individual registered nurse who violates a provision of this Part whenever the Board determines the public interest will be best served by alternatives to the disciplinary process".

#### **Q.** What does RNP provide?

**A.** The RNP provides on-going monitoring of the chemically dependent, the physically impaired and the mentally impaired nurse, which is necessary to ensure public safety. This monitoring begins when the impairment is identified, proceeds through the treatment process and continues through the recovery period for as long as necessary.

**Q.** How can a nurse be referred to the Recovering Nurse Program?

**A.** Nurses may refer themselves to the RNP. Employers, colleagues, family or friends may refer nurses to the program. Nurses may be ordered into the program by the Board (non-confidential).

Whatever the source of the referral, most important is early intervention. The earlier in the disease process that a nurse receives treatment, the greater the chance of success for the nurse, and the less likely it is that a patient will be harmed by an impaired practitioner.

To safeguard the life and health of the citizens of Louisiana by assuring persons practicing as registered nurses and advanced practice registered nurses are competent and safe.

### Compliance/Practice Issues

#### Recovering Nurse Program (Cont...)

A nurse who is believed to be practicing nursing while impaired should be reported to the Recovering Nurse Program. A nurse who fails to report a nurse believed to be practicing while impaired is guilty of aiding and abetting the violation of the nurse practice act. (L.R.S. 37:921 (5) L.R.S. 37:931 provides civil immunity. "A. There shall be no civil liability and no licensee or other individual shall have a cause of action or a claim for damages against any person or institution providing information to the Board, its members, officers, designated agents, representatives, or employees, where the individual or institution acts without malice and in the reasonable belief that such information is accurate".

### **Educational Issues**

#### **Out of State Nursing Program**

In accordance with Louisiana Revised Statutes 17:1808, an out of state institution of higher learning may not offer courses in Louisiana unless registered with the Louisiana Board of Regents. This includes students in clinical nursing courses at undergraduate and graduate levels. Further, the Louisiana State Board of Nursing has standards for the clinical practice of students and must approve the nursing program, the clinical practice sites and the students prior to their engaging in clinical practice in Louisiana.

#### Criminal Background History on Students in Clinical Nursing Courses in Louisiana

Effective August 2005, students admitted to a clinical nursing course in a Louisiana program, or out-of-state program approved for clinical practice in Louisiana, preparing for RN licensure shall file an application to the LSBN and have a criminal background history using fingerprints. The criminal background history will be conducted by the Louisiana State Police and the Federal Bureau of Investigation. Criminal background history will continue to be conducted on each graduate prior to licensure.

#### Preparing Candidates for RN and/or APRN Licensure

Louisiana has Twenty-three (23) nursing programs in twenty institutions preparing candidates for registered nurse (RN) licensure. There are eight programs preparing candidates for Advanced Practice Registered Nurse (APRN) licensure. Of the 23 programs, one awards a diploma in nursing, nine award an associate degree and thirteen award a bachelor's degree. Twenty-two of the 23 undergraduate nursing programs are nationally accredited by either the National League for Nursing Accrediting Commission (NLNAC) or the Commission on Collegiate Nursing Education (CCNE). The NLNAC accredits associate degree, baccalaureate degree and masters degree programs while the CCNE accredits only baccalaureate and higher degree programs. Two undergraduate programs and one graduate program hold both NLNAC and CCNE accreditation.

The quality of the nursing programs in Louisiana is excellent as documented by the consistently above national average licensure examination passing rates and the leadership roles assumed by the graduates of undergraduate and graduate programs in a variety of health care institutions. Louisiana residents comprise an overwhelming majority of students enrolled in these programs in nursing.

### **Educational Issues**

#### NCLEX-RN Pass Rate for 2004

Louisiana had the second highest percentage passing rate among all National Council of State Boards (NCSBN) jurisdictions on the NCLEX-RN examination for 2004. Louisiana has consistently ranked among the top 10% for passing rates for the past ten years. The average pass rate for first time candidates from nursing programs in Louisiana was 90.6% for 2004 while the national average was 85%. The following table presents the passing rate for 2004 by educational institution:

### Questions on Online Accounts and Services

#### Q: What are the advantages of having an online account?

A: There are several advantages to having an online account. Listed are:

1. To be able to perform online renewals of your licenses.

2. To be able to make address changes to your home and business addresses.

3. To receive important information through e-mail about upcoming events or activities with the Board.

We will continue to improve and add new services to the site to provide nurses with better options for Board processes.

#### **Q:** What if I do not have a computer or internet connection. How can I create an account or perform online renewals?

**A:** You may contact your employer and in most cases they can provide you with a computer to use to create an account or perform online renewals. An advantage to this option is that co-workers may be able to help you if they have done it themselves. Alternatively, you could also go to a local library and use a public computer to do these same services.

## Q: I have been to the website and cannot find where to create an account. Where do I go?

A: Once you navigate to the http://www.lsbn.state.la.us website on the left menu is an option **Online Services**. Click here to enter the online services page. The first option there is the **Nurse Account Signup**. Click here to enter the nurse account signup to begin the process of obtaining an LSBN Online Account.

#### Q: What information is required to open an online account?

**A:** Your License Number, Date of Birth, Social Security Number, and a Personal Identification Number. You will receive your PIN number upon receiving your initial licensure packet. If you were already licensed you would have received your PIN number on the back of your last renewal application. If you did not create an account for this past renewal season or misplaced your PIN letter from the initial licensure packet then you can contact Cherie Brown at (504) 838-5316 for a new PIN letter. We cannot give out PIN numbers through email or phone conversations.

#### Q: When entering information on the Nurse Account Signup screen I get the message "You must enter a correct value in all of the fields" what does this mean?

**A:** Usually this message indicates that the information entered may not be entered correctly. Your Social Security Number must be in the form of 123-45-6789 or 123456789. Your license number must be in the form of RN123456 or 123456. If it is a 5 digit number then RN012345 or 12345. If it is a 4 digit number then RN001234 or 1234. Your date of birth must have a full 4 digit year and use a leading zero for single digit months or days i.e. 05/05/1963.

### Questions on Online Accounts and Services

#### Q: I have entered all my information correctly and I get this message "You do not validate as a registered nurse in our system. Please try again or contact the board to verify that your information in our system is correct."

A: Make sure that all your information is entered correctly. If that is indeed the case it is likely the information in our system is not correct and you will need to contact the board at Cherie Brown at 504-838-5316 to have your information corrected.

## Q: My account is created but I cannot remember my password. What do I do?

**A:** When you try to login to a service and you get to the login screen there is a link at the bottom that states "If you lost your password click here." Click the link and you will be prompted for your Social Security Number and Email address. Upon entering both of those you will be sent an email with a new random password. You should then login with the new password and change your password to something more familiar to you. If you have changed your email you will need to contact Cherie Brown at 504-838-5316 to have your email address updated and then you can use the lost password page to receive a new password.

## Q: I would like to change my email address or update the way I receive the Examiner. How do I do this?

A: At the http://www.lsbn.state.la.us website on the left menu click **Online Services**. In the middle of the page is the **My Profile** link. Click there to change your email address or update the method to receive the Examiner.

## Q: What are the advantages of renewing online as opposed to sending in the application?

A: The main advantage of renewing online is Convenience. The online process only takes a few minutes to complete as opposed to filling in the application and mailing it in to the office. Speed is another advantage. Your application is processed within 20 minutes as opposed to having a 7-10 day turn around time. Also, if for some reason we have to send the application back that would add more time to the process as well. Finally, you will receive your license much quicker than the paper application process as a result of the quick turn around times.

## Q: I am an APRN and I can renew my RN online but why not my APRN license?

A: Currently we are in the process of implementing APRN renewals online. We would very much like to have them ready for the next upcoming renewal season. If we do we will post it on our front page of the website and on the welcome page of the Online Renewal section to inform people that we have this process ready. We will also send out an email to those who have already signed up informing them of the APRN renewal process.

### Questions on Online Accounts and Services

#### Q: I have been to the website and cannot find where to renew my license. Where do I go?

A: Once you navigate to the http://www.lsbn.state.la.us website on the left menu is an option **Online Services**. Click here to enter the online services page. The last option there is **Online Renewals**. Click here to enter the Online Renewal Welcome page to begin the process of renewing your LSBN License(s).

#### Q: I have entered my login information but I get the message "SSN is not a valid SSN." What is wrong?

**A:** You must make sure your Social Security Number is in the form of 123456789 or 123-45-6789.

#### Q: I have entered my login information but get the message "The SSN and/or Password cannot be found in the database. Please retry your login or Signup if you have not done so." What does this mean?

**A:** One of two things:

 You have not created an account. You can begin the process by clicking the new user link below the password field. Or;
Your password is not correct. If you have forgotten your password then you need to click the link where it states "If you have lost your password click here."

#### Q: I have entered information on one of the renewal process steps but when I click next it does not go to the next page. What do I do?

A: On each step of the renewal process you will be required to fill out fields or select options. At the top of the page in red is a message indicating problems with the current step. Read the text and correct each problem until you are able to proceed to the next page. The system will not let you go to the next page until each step is filled out correctly. Most problems occur due to skipping a question or leaving a field blank.

## **Q**: I have reached the Summary page and noticed that some information is not correct. What do I do?

A: You may click the back button to return to previous pages and correct information that is not correct. While at the summary page review everything and make sure it is correct. When you check the attest box and click next to go the payment process you will not be able to go back and correct information at that point. Please be sure to carefully verify that all information on the Summary page is correct before proceeding.

## Q: I have entered all my credit card information but it is not letting me advance to the next step. Why?

**A:** Please make sure the following information is entered correctly:

1. Make sure the name on the card is entered into the field exactly as it is written on the card

2. Make sure the Credit Card number is entered into the field with no spaces or dashes.

3. Make sure the correct Credit Card Type is selected in the pulldown menu.

4. Make sure to select the correct month and year from the pulldown lists

5. Make sure the correct address on record for the card is entered in the address, city, state, and zip fields.

#### **Q:** I have submitted my credit card transaction and I get this message "There has been a problem with the Credit Card Transaction. Please review the message below and go back and try your transaction again."

A: This can occur for several reasons:

1. You are using a check card which is not accepted at this time. The system will only accept valid credit cards by Visa, MasterCard, American Express, and Discover.

2. The information entered is not correct at which point you can go back and check to make sure all the information is entered correctly.

There is a problem with the credit card processing center.
The credit card is expired. You can go back and try another credit card.

# Q: I have submitted my information but the computer crashed or a web page error occurred and I am not sure if my transaction went through. What can I do?

**A:** You may call the board at Lilie Rodgers at (504) 838-5499 and we may be able to verify that your transaction has gone through and correct any errors if they occurred.

#### Q: I have completed the renewal process and I am at a page with the invoice number and stating my credit card transaction was successful. Should I print this page?

**A:** This is the confirmation page and you should print this out for your records. If for some reason there is a problem on our end we can use this information to verify that you had gotten a successful transaction message. This will help you to avoid having to pay late fees or have your license go delinquent.

#### Q: I have renewed online but have not received my license. What do I do?

A: First verify that your license was updated using the Online Verification System. Online renewals take about 20 minutes to be processed. The licenses are then sent out by postal mail. Please allow 7-10 days for delivery of your license before contacting the board. If you still have not received your license then contact us. In most cases it was because of an address error which may need to be corrected. The address change is a part of the renewal process but may be missing an apartment number or some other important piece of the address that was left out. Also, if you change addresses at any time during the year you can fill out a form on the web or change your address online using the Address Change Service. You may be missing important information if your address is not up to date. All information from the board is sent to the address we have on record so it is important for you to keep this information up to date.

#### LEGAL DUTY TO NOTIFY THE BOARD OF NAME OR ADDRESS CHANGE

Every RN with a Louisiana license is responsible for immediately notifying the Board office in writing of any name or address change. Correspondence from the Board, such as licensure renewal, notice of Board Actions printed in The Examiner which may affect the license, as well as disciplinary charges and notice of hearing are mailed to the last known address of the Registered Nurse. Therefore, failure to properly notify the Board of one's current address can result in a lapsed license, noncompliance with regulations of the Board, or disciplinary action in the nurse's absence.

NOTE: The rules of the Board provide that correspondence to the last known address is legal notice. If the mailing is not returned to the Board, the legal presumption is that the RN has been properly notified of the mailing. The responsibility rests with the licensee to assure that the Board has a current address on file at all times. A change of address form appears on the back page of each issue of The Examiner.
