FROM THE EXECUTIVE DIRECTOR

Self-regulation is the hallmark of a profession



As we celebrate throughout this year, the 100 year anniversary of the regulation of nursing practice in Louisiana and as we are in the midst of the 2012 Legislative session, I believe it is important to reflect upon what the regulation of nursing practice means to all of us and its

significance today and into the future.

Isabel Hampton Robb, one of the founders of modern America nursing and the first President of the American Nurses Association, stated in her inaugural address, “Self-regulation is the hallmark of a profession”, and called upon the nurses of our country to organize for the purpose to enact state legislation establishing standards for nursing education and practice. Sixty-four (64) nurse leaders accepted that call and came together to organize the Louisiana State Nurses Association whose purpose has been and continues to be the enactment of legislation that promotes the standards of the nursing profession.

But what does ‘self-regulation’ really mean and what does that look like in the 21st century? Just because we have a nurse practice act which establishes a Board comprised of RNs and APRNs, does it mean that we have achieved it? I think not. To be self-actualized as a profession means much, much more.

Can we say today that we are in control of our own destiny as a profession? Are we confident that in any given legislative session, only legislation in alignment with the values of the nursing profession will pass or are we vulnerable to the passage of legislation that may actually undermine the standards of nursing education and nursing practice that we have achieved.

History tells us that it takes organization and a unified vision to move the profession forward. Have we learned from the lessons passed or do we splinter our efforts and act in ways that actually divide the profession and work in cross purposes to the advancement of the profession.

Self-regulation is a public trust and comes with responsibilities to assure the public a competent registered nurse or advanced practice registered nurse. You have the responsibility to be competent and to practice within the scope of nursing practice. The Louisiana State Board of Nursing is responsible for establishing and enforcing standards of practice and education and to safeguard Louisiana citizens. The profession has a responsibility to come together to speak in a unified voice and unified vision in the public and political arenas.

The Louisiana Action Coalition for the Future of Nursing gives us an opportunity to come together as nursing leaders with many influential stakeholders, including consumers, healthcare providers, governmental officials and payers. Let’s not mess it up!

Let’s make sure we speak with a unified voice on the needs of Louisiana citizens for a qualified, competent workforce. Only then may we become truly ‘self-regulated’.

LSBN Annual Report

The 2011 Louisiana State Board of Nursing Annual Report is Available Online

The LSBN Annual Report is a mechanism that is used to inform the Governor, Members of the Legislature, other state agencies, the health care community, academic institutions and the citizens of Louisiana about the work that is being done by Board Members and Staff to safeguard the life and health of the citizen's of Louisiana by assuring persons practicing as registered nurses and advanced practice registered nurses are competent and safe, as well as a forum to share information about Louisiana's RN workforce and nursing education capacity.

Did You Know?

- In 2011 there were over 57,000 RNs licensed to practice in Louisiana
- Over 2,200 students graduated from Louisiana's pre-RN licensure programs during the 2010-2011 academic year
- The passage rate for graduates from Louisiana's pre-RN-licensure programs on the National Council Licensure Examination for Registered Nurses has exceeded that of the national pass rate over the past 4 years
- Over 3,000 qualified applicants were admitted to Louisiana's pre-RN licensure programs in 2010-2011
- Over 1,400 qualified applicants were not admitted to Louisiana's pre-RN licensure programs for one or more of the following reasons: lack of available qualified faculty, limited number of budgeted faculty positions, faculty salaries were not competitive with salaries in the clinical or practice setting, and a lack of available clinical sites.

APRN Corner

Collaborative Practice Agreements

Keep your collaborative practice agreements up to date with LSBN. As per LAC 46:XLVII.4513.D.7 an APRN must notify the board in writing within 30 days of all changes regarding practice sites and/or collaborating physicians. Failure to request approval for these changes may result in disciplinary action.

Are you licensed as an APRN under commensurate requirements

Are you licensed as an APRN under commensurate requirements (considered “grandfathered”)? Keep in mind that throughout the year that clinical practice hours and continuing education are required yearly for renewal. Both clinical practice and CEs must be at the advanced level and directly related to the scope of practice in the specialty area for which commensurate requirements and licensure has been granted. Faculty can use hours of direct clinical supervision of students for clinical practice if the clinical supervision is related to the faculty member’s advanced role and population foci.

Got Recertification?

Continued competence requirements of the Louisiana State Board of Nursing include maintaining advanced practice recertification. Provide evidence of your recertification with the new expiration date to our office via fax or email as soon as you receive it in order to be in compliance with current regulations. (APRNs licensed by grandfathering must meet the requirements for renewal as specified in LAC 46:XLVII.4507.E.2). It is the APRN’s responsibility to provide the information to the Louisiana State Board of Nursing.

Temporary Permit

If an APRN applicant has applied for a temporary permit and has been approved, the temporary permit number assigned may be verified under the “Licensure Verification” tab on the LSBN website. It is valid for a maximum of 120 days. If the applicant is unsuccessful in taking the national certifying exam, the applicant must immediately cease practicing as an APRN applicant and the permit immediately becomes invalid and inactivated.

APRN applicants must practice “under the guidance of a licensed APRN, physician, dentist, or approved preceptor within the practice specialty and functional role of the applicant” as per LAC 46:XLVII.4507B(1). Additionally, the applicant must use the title “advanced practice nurse applicant” or “APRN applicant” while working under the temporary permit according to LAC 46:XLVII.4507B(2). Once an APRN is fully licensed, he/she may submit a collaborative practice agreement and application for prescriptive authority. It is emphasized that according to our regulations, the APRN **who engages in medical diagnosis and management** must have a collaborative practice agreement (LAC 46:XLVII.4513B) which is approved by and on file with the Louisiana State Board of Nursing.

Prescriptive Authority

An APRN must apply for prescriptive authority and receive written approval by the board before engaging in medical diagnosis and management including prescribing drugs and therapeutic devices as recommended by clinical practice guidelines and within the parameters of the collaborative practice agreement. You may apply for prescriptive authority after you have become fully licensed. Once you are approved, a prescriptive authority/PA number is assigned to you which is to be used on all prescriptions.

Major Revisions to LAC 46:XLVII.3331 Denial or Delay of Licensure, Reinstatement, or the Right to Practice Nursing as a Student Nurse went into effect on March 20, 2012

LSBN has witnessed an increase in the number of applicants with a prior serious criminal action and/or substance use disorder applying for licensure, reinstatement, and the right to practice as a student nurse. Since the Board has a duty to exclude individuals who pose a risk to public safety, the rules will now deny applicants who have been convicted (or similar plea) of felony crimes of violence, sex offenses, and crimes involving the distribution, manufacture and production of drugs. Prior to the revision, grounds for permanent denial were only for crimes of violence and crimes involving the distribution of drugs. The revised rule also permanently denies applicants convicted of certain felony property crimes such as Medicaid Fraud and Identity Theft.

The second addition to the rule will deny applicants for a minimum of five years following the final disposition of the criminal case for any other felony convictions or for two or more misdemeanor crimes which reflect the inability to practice nursing safely. Additionally, applicants will be denied for a minimum of five years following a misdemeanor conviction and the existence of aggravating circumstances including but not limited to ongoing substance abuse.

Finally, the grounds for delay of an applicant have been increased to include recent diagnosis or treatment for substance use disorders. This will allow individuals to demonstrate rehabilitation prior to entering the challenges, temptations, and added stressors of nursing school and or licensure.

In 2010, there were 1,353 qualified applicants not admitted to Pre-RN Licensure Programs (LSBN Annual Report, p. 31). The revisions to this chapter will provide admission guidelines for schools of nursing and assist prospective students in determining their eligibility to practice nursing. Please see the attached grid for more specific information as well as links to the crimes of violence and sexual offenses that will result in permanent denial.

Applicants with a serious criminal history that may not have resulted in a conviction or similar plea will be required to provide evidence that they are fit to practice and that the underlying conduct surrounding the criminal incident(s) will not prevent the practice of safe nursing care.

Alternate clinic sites other than the school setting are approved during the summertime to allow for continuity and appropriate follow-up care.

Telemental health technology is identified as the health care delivery of diagnosis, consultation, treatment, and transfer of nursing and medical data using interactive telecommunication technology that enables the APRN and patient at two locations separated by distance to interact via two-way video and audio transmissions simultaneously.

When delegating to trained, unlicensed school personnel (in the school setting) the administration of nutrition via a gastrojejunostomy tube connected to an infusion pump, the school registered nurse retains the responsibility and accountability to assure the delegated intervention is performed in accord with the following:
 - a. Established standards of practice, product manufacturer's recommendations, agency policies and procedures;
 - b. laws governing the practice of registered nursing in Louisiana (LA R.S. 37:911 et seq);
 - c. Louisiana Rules and Regulations, Title 46, Professional and Occupational Standards, Part XLVII. Nurses, Subpart 2. Registered Nurses;
 - d. Laws governing the practice of school registered nursing in Louisiana (LA R.S. 17); and
 - e. Louisiana Handbook for School Administrators (Title 28, Education, Part CXV. Bulletin 741);
 - f. Physician's orders.
- (2) That it is within the scope of practice for a school registered nurse to delegate to trained, unlicensed school personnel (in the school setting) the administration of medication via a gastrojejunostomy tube contingent upon the school registered nurse's evaluation of the student's condition and evaluation of the unlicensed school personnel's competency. When delegating to trained, unlicensed school personnel (in the school setting) the administration of medication via a gastrojejunostomy tube, the school registered nurse retains the responsibility and accountability to assure the delegated intervention is performed in accord with the following:
