### Legislative Highlights 2007

The following bills were enacted in the 2007 Legislative Session and may be of interest to you:

#### **HB 246 (became Act 293)**

Provides for the certification of medication attendants to work in licensed nursing homes. This bill establishes a pilot program that shall authorize certification of medication attendants to perform certain functions in licensed nursing homes until August 1, 2011. Provides for the authorization of the Dept. of Health and Hospitals to certify medication attendants to work in licensed nursing homes.

New law authorizes certified medication attendants to deliver and administer certain medications under the supervision of a licensed nurse by the following methods:

- (I) Orally.
- (2) Topically.
- (3) Drops for eye, ear, or nose.
- (4) Vaginally.
- (5) Rectally.
- (6) Transdermally.
- (7) Via oral inhaler.

New law prohibits certified medication attendants from administering controlled dangerous substances; medications by intramuscular, intravenous, or subcutaneous routes; medications by the oral inhalant aerosol route; and medications ordered on an as-needed basis.

New law further prohibits certified medication attendants from receiving or assuming responsibility for reducing to writing oral or telephone orders, performing a task involving the administration of medication if the medication requires an assessment of the patient's physical status, and performing a task involving the administration of medication if the patient is unstable.

New law requires the department, in conjunction with an advisory committee, to promulgate rules and regulations by March 31, 2008, for the enforcement of new law, including an establishment of an administration course which contains a minimum of one hundred hours. Members of the advisory committee include one representative of each of the following:

#### HB 246 (Cont...)

Board of Supervisors of Community and Technical Colleges, and Louisiana Nursing Home Association.

New law requires that a permanent register of all certified medication attendants be maintained by the department. Further requires any nursing home utilizing a medication attendant to verify the attendant's current certification in the registry.

New law provides for the qualifications an applicant for the medication administration course must meet.

New law terminates on August 1, 2011. Effective upon signature of governor (July 9, 2007). (Adds R.S. 37:1026.1-1026.9)

#### HCR 202

Request the Louisiana State Board of Nursing to study the scope of practice of registered nurses to work as qualified medical personnel to perform medical screening examinations(MSE) in rural hospitals and report its findings to the House and Senate Health and Welfare Committees by March I, 2008. The current interpretation of the Louisiana State Board of Nursing is that only APRNs are authorized to perform MSEs. Rural hospitals brought forth this resolution in a concern that rural hospital settings can ensure that rural residents have access to hospitals with sufficient personnel consistently available to meet EMTALA regulations. The resolution charges the Board to conduct a study of this matter with a committee comprised of a representative from each of the following:

#### SCR109

Request the Senate and House committees on health and welfare to study and make recommendations with respect to a process for dealing with issues of the scope of practice for various medical and health care disciplines. Requires written report by 1/1/08.

## Legislative Highlights 2007

#### SB282 (Became Act 274)

Provides for the timely reporting of impaired health care professionals

New law finds that impaired health care professionals represent a threat to the public and that it should be an important function of professional licensing boards to protect the public from health care professionals who are or may be impaired.

New law provides definitions to be used in new law, including a definition of the term "professional licensing board" as the La. State Board of Medical Examiners, La. State Board of Nursing, the La. State Board of Dentistry, or the La. State Board of Examiners of Psychologists.

New law provides that, except in certain circumstances, a health care entity shall report each instance in which the health care entity takes an adverse action against a health care professional due to impairment or possible impairment or accepts the surrender of clinical privileges, the resignation of employment or a contractual relationship, or the withdrawal from participation in a health care training program of or by a health care professional under certain conditions.

New law provides that a report shall not be required when a health care professional is granted a leave of absence for evaluation or treatment of impairment or possible impairment provided specified conditions are met.

New law provides that the reports shall be in writing and shall include but not be limited to the following:

- The name, address, telephone number, and category of license of the health care professional.
- (2) The date and nature of the action taken and a description of the acts or omissions or other reasons for action.
- (3) Other information regarding the circumstances of the action as the department or the professional licensing board deems appropriate.

New law provides the reports shall be made to the appropriate professional licensing board within 72 hours of the adverse action, surrender, resignation, or withdrawal.

New law provides for the confidentiality of such reports and specifies such reports received by the professional licensing boards shall not be deemed to be or be treated as public records.

#### SB282 (Cont...)

New law further provides a reference to such new law exemption in the laws relative to public records.

New law for the limitation of liability for mandatory reporters (health care entities and employees and agents of such entities), unless the reporter knew of the falsity of the information.

New law provides that any information reported by a health care entity is intended to be used solely by the professional licensing board in furtherance of their statutory obligation.

Effective August 15, 2007.

#### SCR97

Requests Senate and House committees on health and welfare to jointly study the medical staffing agency industry in Louisiana to ascertain the effect of medical staffing agencies on the delivery of quality health care in this state and to determine whether the industry should be subject to registration, licensure, or other regulation, and report its findings and recommendations, including proposed legislation, to the governor and the legislature by 12/31/07. Requires the joint committee to hold its first meeting on the study no later than 7/31/07 and charges the committee to seek the advice, input, and recommendations of the following:

> Department of Health and Hospitals Louisiana Health Care Commission Louisiana Hospital Association Louisiana State Board of Nursing Louisiana Staffing Association Louisiana State Medical Society Louisiana State Nurses Association Louisiana State Board of Practical Nurse Examiners

### Notifications

#### ATTENTION Nurses Who Have Student Loans

If you borrowed money for your nursing education through the Louisiana Education Loan Program (Lela) anytime on or after July 1, 2001, you may be eligible for 0% interest.

The HELP Nurses (Higher Education Loan Program) is being introduced by Lela to help retain nurses and nurse educators in Louisiana by providing them with interest-free federal education loans. HELP Nurses is funded and administered by Lela at no cost to the state. Lela, a division of the Louisiana Public Facilities Authority, is Louisiana's nonprofit student loan provider.

If Lela is your lender and you are still repaying your loan, go to their website (<u>www.lela.org</u>) or call them at 1-800-228-4755 to see if you qualify for an interest waiver or for more information.

#### ATTENTION Advanced Practice Registered Nurses

The National Provider Identifier (NPI) is a Health Insurance Portability and Accountability Act (HIPAA) Administrative Simplification Standard. The NPI is a unique identification number for covered health care providers. Covered health care providers and all health plans and health care clearinghouses will use the NPIs in the administrative and financial transactions adopted under HIPAA. The NPI is a 10position, intelligence-free numeric identifier (10-digit number). This means that the numbers do not carry other information about healthcare providers, such as the state in which they live or their medical specialty. Beginning May 23, 2007 (May 23, 2008, for small health plans), the NPI must be used in lieu of legacy provider identifiers in the HIPAA standards transactions.

According to the U. S. Department of Health and Human Services, Centers for Medicare & Medicaid Services, if you are a health care provider who bills for services, you probably need an NPI. If you bill Medicare for services, you definitely need an NPI. Getting an NPI is free. For additional information, refer to:

## The Recovering Nurse Program

#### What Is The Recovering Nurse Program?

The Recovering Nurse Program (RNP) may be a confidential, voluntary alternative to formal disciplinary action for registered nurses who may be impaired due to the habitual or regular use of drugs and/or alcohol. Nurses may also be ordered into the RNP for monitoring when there is disciplinary action.

#### Why Was The Recovering Nurse Program Established?

It is estimated that 10 to 14% of nurses are dependent on alcohol and/or mood altering drugs.

A registered nurse who habitually or regularly uses alcohol and/or other drugs presents a potential danger to his/her patients because the use of chemicals can impair the nurse's ability to safely practice nursing.

There are currently 395 participants in the Recovering Nurse Program. Of the 395, 236 voluntarily entered the program; they are in the program confidentially with an active, unencumbered license.

In 2006, 28 participants successfully completed the program.

On occasion, registered nurses are reported to the Board for submitting a positive drug screen without a prescription. If a facility has a positive drug screen and the nurse is unable to produce a legitimate prescription, the facility reports this to the Board. Please be aware that if a nurse takes a family member's prescribed narcotic or takes a narcotic from an outdated prescription, and tests positive, he/she may be contacted by RNP to determine if there is a substance problem.

#### Administrative Issues

**Approved** to direct board staff to implement the distribution of "The Examiner" via electronic format to all licensees for whom the board has email addresses.

### Major Motions of the June 11-13, 2007 Board Meeting

#### Education Issues

**Approved** the Louisiana State University Health Sciences Center BSN Program Major curriculum change.

**Accepted** notification that the Intercollegiate Consortium for a Master of Science in Nursing (ICMSN) has changed structure to include only three schools: McNeese State University, Southeastern Louisiana University, and the University of Louisiana at Lafayette, and approved the ICMSN request that the three schools be referenced as one entity for all Louisiana State Board of Nursing matters, including annual reports.

**Recommended** appointment of a task force and invite chairs and/or department heads or the appropriate resource person from the schools to a meeting to revise the annual report form and that is subsequently be reproduced in an electronic format. Further, the task force should include Dr. Donnie Booth as the representative from the Nursing Supply and Demand Commission and the President of LaCane (or their representative).

**Recommended** to initiate rulemaking for use of a 60 minute period to equal one (1) contact hour of continuing education.

**Approved** policy and procedure for "Conditional Approval for Programs in Nursing".

#### Other Issues

**Accepted** update of the 2007 Regular Legislative Session and tracking report of all bills currently being monitored by Louisiana State Board of Nursing.

Accepted the Memorandum of Understanding (MOU) between Department of Health and Hospitals (DHH) and the Louisiana State Board of Nursing regarding licensing and registration of health professionals in a disaster and authorized the Executive Director of the Louisiana State Board of Nursing to enter into an agreement with DHH.

**Approved** the addendum for Datacenter Virtual Hosting Services proposal as a component to ensure business continuation in the event of a disaster.

#### **Compliance Issues**

**Approved** the policy on Advanced Practice Registered Nurses (APRN) in the Recovering Nurse Program (RNP) and changes to the RNP program specifications.

#### **Nurse Practice Issues**

**Recommended** the establishment of a Task Force to identify the RN role in the assessment to determine/certify false labor. The Task Force will include:

#### LEGAL DUTY TO NOTIFY THE BOARD OF NAME OR ADDRESS CHANGE

Every RN with a Louisiana license is responsible for immediately notifying the Board office in writing of any name or address change. Correspondence from the Board, such as licensure renewal, notice of Board Actions printed in The Examiner which may affect the license, as well as disciplinary charges and notice of hearing are mailed to the last known address of the Registered Nurse. The responsibility rests with the license to assure that the Board has a current address on file at all times. Failure to properly notify the Board of one's current address can result in a lapsed license, noncompliance with regulations of the Board, or disciplinary action in the nurse's absence. **Correspondence to the last known address is legal notice.**
