The Louisiana Center for Nursing

Registered nurses represent the largest segment of the healthcare workforce. Registered nurses are the health care professionals that spend the most time providing direct patient care to patients and are indispensable to patient safety (Hassmiller, 2009). Despite the current economic climate and its impact on the nursing shortage, a study conducted by Buerhaus, Auerbach, and Staiger (2009), indicated that although some parts of the nation may currently be experiencing a respite in terms of the nursing shortage, there continues to be a projected shortage of 260,000 RNs by 2025. Therefore, it is imperative that registered nurses, the healthcare industry, policy makers, and healthcare consumers do not become complacent and feel that the nursing shortage is over. According to the Industry and Occupational Employment Projections for 2006 thru 2016, the occupation with the greatest projected growth in Louisiana is registered nurses. There are expected to be 13,510 new openings for registered nurses in the state of Louisiana by 2016. In light of these findings, it is essential that strategic measures are taken to ensure that there is an adequate workforce to meet the current and future healthcare needs of the citizens of the state of Louisiana.

Registered nurses must be prepared to participate in the administration of a future healthcare system that may be very different from the healthcare system we have been accustomed to as a profession and a society. Registered nurses, advanced practice registered nurses, and nursing faculty must be prepared to take on the challenge of healthcare. Registered nurses must be equipped with the necessary tools to make appropriate data driven decisions that will impact health policy; we must embrace the use of health care technology; and we must prepare ourselves to participate in a health care system that could potentially be based on a pay-for-performance model which measures nursing care performance and seeks to reward improvements in quality and high performance based on pre-established outcome measures (Alliance for Health Reform, 2007).

An adequate supply of registered nurses and advanced practice registered nurses is inherent in protecting the public health, safety and welfare of Louisiana citizens. The Louisiana State Board of Nursing (LSBN) has a long history of reporting demographical data relative to Louisiana's nursing workforce to the Governor, legislature, and other state agencies and public stakeholders, yet little is known about the projected need for registered nurses based on nursing demand data, educational preparation (Diploma, Associate Degree, Baccalaureate, Masters, Doctoral), and advanced practice (Nurse Practitioners, Certified Registered Nurse Anesthetists, Certified Nurse Midwives, Clinical Nurse Specialists) in Louisiana. Many states, including our neighboring states of Mississippi, Florida, and Texas, have addressed nursing supply and demand issues through the efforts of nursing workforce centers. In the 2008 Louisiana Regular Legislative Session, Senate Resolution 152, authored by Senator Gerald Long and co-authored by Senators McPherson, Mount and Michot, urged and requested LSBN to establish a nursing workforce center in Louisiana. This resolution expands the charge to the Board to be involved not only with the credentialing of individuals that are licensed as registered nurses and advanced practice registered nurses, but additionally with activities related to generating, analyzing and maintaining nursing supply, nursing demand, and nursing education data in order to determine the projected RN nursing workforce needs for the state of Louisiana. The, Louisiana Center for Nursing (LCN), which falls under LSBN, was established to ensure that there is an adequate nursing workforce to meet the current and future healthcare needs of the citizens of the state of Louisiana. Nursing workforce issues are inclusive of developing methods for the collection and analysis of nursing supply and demand data for the state of Louisiana, expanding nursing education capacity, and addressing nursing practice issues in terms of recruitment, retention, and patient outcomes, as well as the facilitation of data driven decision making related to healthcare policy issues. Licensure and regulatory functions are not components of LCN's mission or function. Education Actions

Approved to amend the previously approved November 19, 2009 Special Call Education Committee Meeting report to reflect that D. Porche and L. Agosta were charged with drafting clear and specific recommendations to the Board regarding modifications to Chapter 45.

Approved the revisions to §3515 Faculty Qualifications to initiate rulemaking.

Approved that the Board would establish a Task Force to revise Chapter 45. Advanced Practice Registered Nurses.

Approved that the eleven (11) member Task Force is composed of representative from both the Practice and Education arenas and include:

Dr. Lucie Agosta – *Practice*

Dr. Demetrius Porche – *Education*

LAMP representative – *Practice*

(3) Representatives from LACANE(including 2 from the public sector and 1 from the Private sector) – *Education*

LANA representative – *Practice*

(1) Representative to be appointed from the Board

Dr. Robert Bass invited as Ex-Officio member

Approved to include a representative from LONE and exclude the representative from the Board.

Approved that the purpose of the appointed task force is to propose rules and regulations for promulgation that revise Chapter 45 to ensure congruence with national standards and guidelines, current regulatory and certification issues, contemporary and future advanced practice models of care delivery, and current and future educational trends which are evidence based as appropriate. In addition, the specific taskforce charge shall include the following:

Review the following documents to identify the policy changes needed for APRN Practice and nursing education:

- a. AACN Essential
- b. NCSBN Competence Document
- c. Advanced Practice Certification requirements for APRNs
- d. SACS accreditation documents
- e. NLNAC and CCNE accreditation standards
- f. Literature on current and future practice and education trends

Analyze the policy gap incongruence between Chapter 45 and APRN education Certification and practice.

Propose policy modifications to Chapter 45 that address the current licensure, Accreditation, certification, practice and educational issues.

Accepted the recognition of the COA and add this group to the list of documents to identify the Policy changes needed for APRN practice and Nursing education.

Accepted that the Board utilizes the National Council Consensus Model as a guide to framework the revisions of Chapter 45 in the development of a position paper.

Acknowledged the receipt of the Notice of Intent from Herzing University New Orleans for Approval of Feasibility Study and Step I of Procedure to Establish an ADN Program and the Board has requested more information.

LEGAL DUTY TO NOTIFY THE BOARD OF NAME OR ADDRESS CHANGE

Every RN with a Louisiana license is responsible for immediately notifying the Board office in writing of any name or address change. Correspondence from the Board, such as licensure renewal, notice of Board Actions printed in The Examiner which may affect the license, as well as disciplinary charges and notice of hearing are mailed to the last known address of the Registered Nurse. The responsibility rests with the licensee to assure that the Board has a current address on file at all times. Failure to properly notify the Board of one's current address can result in a lapsed license, noncompliance with regulations of the Board, or disciplinary action in the nurse's absence. **Correspondence to the last known address is legal notice.**
