Major Motions of the December 17-19, 2007 Board Meeting

Education Issues

Accepted the proposal for an externship elective as presented by William Carey University School of Nursing.

Approved the request by Delgado Community College/ Charity School of Nursing for an RN Refresher Course with an addendum that the grading criteria be reviewed along with the theory passing standard and the textbook

Approved the following recommendations:

Recommend that the LSBN representatives on the current joint LSBN and LSBPNE subcommittee bring forward a motion to examine the possibility of an LPN Exit Option for students enrolled in RN programs of nursing.

Recommend that the Board establish a task force to examine the accessibility of general education courses across Louisiana nursing programs to promote faster completion of LPN to RN tracks.

Approved the removal of Southern University BSN Program from conditional approval status and restore to full approval status.

Approved to grant initial approval to Fletcher Technical Community College for the Associate of Science in Nursing Program and approve admission of students for January 2008 with the following recommendation and one suggestion:

That Fletcher Technical Community College acquire on-site secretarial
Support staff for the Division of Nursing and Allied Health.

That Fletcher Technical Community College acquires a Skills Laboratory

Coordinator in the near future.

Approved to present the draft of the revised Undergraduate Degree Programs Annual Report form to LACANE and circulate to schools of nursing across the state for additional comment.

Compliance Issues

Approved revisions to the "Evaluation Policy".

Approved revisions in LAC 45:XLVII.3331 Denial or Delay of Licensure, Reinstatement, or Right to Practice Nursing as a Student Nurse for rulemaking.

Credentialing Issues

Approved Credentialing Committee's recommendation to the Board to direct staff to initiate rule-making and change for the Ist offense for continuing education non-compliance of annual license renewal to be an informal reprimand.

Approved the certification by the Pediatric Nursing Certification Board (PNCB) for the APRN role of Certified Pediatric Nurse Practitioner – Acute Care (CPNP-AC) and for the Louisiana State Board of Nursing to recognize and license nurse applicants applying for the specialty.

Every RN with a Louisiana license is responsible for immediately notifying the Board office in writing of any name or address change. Correspondence from the Board, such as licensure renewal, notice of Board Actions printed in The Examiner which may affect the license, as well as disciplinary charges and notice of hearing are mailed to the last known address of the Registered Nurse. The responsibility rests with the licensee to assure that the Board has a current address on file at all times. Failure to properly notify the Board of one's current address can result in a lapsed license, noncompliance with regulations of the Board, or disciplinary action in the nurse's absence. **Correspondence to the last known address is legal notice.**
