- 1. In reference to Item 4.1: that the Louisiana State Board of Nursing recognize the Masters in Nursing for William E. Sullivan and grant his request for equivalency of a baccalaureate and masters in nursing.
- In reference to Item 4.2: that the Louisiana State Board of Nursing grant continue full approval status to Baton Rouge General Medical Center School of Nursing with three suggestions and two recommendations. Recommendations are to be reported on in the 2001-2002 Annual Report.

Suggestions:

- 1. That the framework articulate the professional standards that guide the program goals.
- 2. That funds be allocated for faculty participation in conferences and workshops to assure knowledge of trends and developments in nursing and nursing education.
- 3. Analyze the need for support staff as one person for direct support to the Director and faculty is minimum.

Recommendations:

- 1. That one additional faculty be added to support the workload of the faculty relative to continuing program and faculty development and evaluation, and to facilitate special projects. (LAC 46:XLVII.3515.A and B.6)
- 2. That tools be developed for the collection of data and that program records document the systematic analysis and use of data for program improvement. (LAC 46:XLVII.3523).
- 3. In reference to item 4.3: that the application to establish a LPN to BSN program by the University of Phoenix College of Health Sciences and Nursing be sanctioned by the Board to continue with the development of the proposed program. Further, University of Phoenix is reminded that in accordance with §3533.2.c, public announcements of the opening of the proposed program and preadmission of students shall not occur prior to the receipt of initial Board approval.

Further more the Board recognized that ULM is not in compliance with LAC 46:XLVII.3515.8. the number of faculty exception should not exceed 20% of the full time nurse faculty in the program. Annual report indicated that the faculty exception at ULM was 24.1% in the future may lead to a change in approval status and this was communicated to ULM.

Ms. Carol Tingle, Interim Director was present to answer any concerns of the Education Committee. Ms. Tingle stated that the joint visit was good for then because Dr. Tate was a known and that help relieved some of the faculty anxiety as they dealt with people on a national level. Ms. Tingle stated that it was a positive experience.
