4513.C Limited
Prescriptive and
Distributing Authority**

D. Humphrey presented the status of the rule-making process. The Louisiana State Board of Nursing may adopt the proposed rule revisions any date after January 20, 2002. A summary of comments received regarding the proposed rule revisions were provided to the Board at its December, 2001 meeting and with the material for this meeting. (Copy on file)

One change was suggested by staff for consistency in language:

LAC 46:XLVII4513.C.3.6a: add after "controlled substances" the words "unless specifically authorized in accordance with LAC 46:XLVII.4513C.4.d.vii(c)."

Staff believes this to be an editorial change to make this section of the previous rules consistent with the proposed rules.

Motion by O. Ferry, seconded, that the Board adopts the proposed rule with the editorial correction.

Voice Vote: Ferry-yes; Crapanzano-yes; Ford-yes; Moody-yes. Motion Carried.

It was noted, that this action needs to be concurred with by the Louisiana State Board of Medical Examiners for joint promulgation.
