Report -Schedule of Fines and Costs for Hearings: This matter remains pending awaiting recommendations from the Administrative Committee. C. Morris informed the Committee of the data gathered and reviewed by the Administrative Committee at the April 27, 2004 meeting on cost accounting. Board staff and Administrative Committee will continue to review costs of hearings.

Revision - Falsification or Failure

At the January 28, 2004 meeting, the decision of the Committee was to add the statement "false statement on application" as a violation to the definition of "other causes" to LAC 46:XLVII.3405. Further discussion was combined with the review on the revisions to LAC 46:XLVII.3405.

New Business:

Revisions to LAC 46:XLVII.3405:

Proposed revisions to Chapter 34. Disciplinary Proceedings: Alternative to Disciplinary Proceedings had been distributed for review pursuant to the decision made by the Committee at the January 28, 2004 meeting. Revisions were discussed. B. McGill informed that Committee that the proposed statement, "J. Adjudged Incompetence..." had been added at the request of B. Morvant. Statement has not been reviewed by legal counsel, which means that the language used may change.

The Committee reviewed information on the four (4) following individual providers granted provisional approval by staff after having met the criteria set by the Board: Steven Cogburn, LPC, Darryl Ducote, LCSW, Gary Magee, PhD, MSW, BCSAC, and NanetteTerrita-Prejean, RN, LPC, LMFT. The Committee granted approval and acceptance.

B. McGill reviewed the approval process for individual providers and inquired whether they wished to make any changes at this time. There were no changes in the process of approval.

This approval brings the total number of individual providers approved by the Board to 50.

Other Matters:

As follow-up to a discussion in a previous Committee meeting, F.

Rosenthal inquired about the following matters:

- Discussion ensued regarding student nurses who had disciplinary action while they were students. Several questions were raised such as, do they continue to have problems after being licensed. Information is not currently available.
- 2. Discussion also ensued concerning criminal background checks for students to being admitted to clinicals. Due to the changes with Joint Commission, this issue was presented to the Education Committee on yesterday (April 27, 2004), a procedure has to be developed by the next Board meeting to be implemented for the fall clinical rotation.
