Page 7, Number 38, the third bullet was changed to read, "On July 25, 2014, Respondent received a verbal warning for failing to appropriately provide nursing care and failing to intervene while caring for a patient on a ventilator in the Intensive Care Unit. On this date, the Respondent's patient's ventilator mode was CPAP in preparation for extubation. The Respondent admittedly

did not enter the patient's room during a time period when patient was in distress.

The Nurse Manager heard a call for Respiratory stat and entered the room. The patient's oxygen saturation decreased to 65% and systolic blood pressure had decreased to the 80's. The Nurse Manager removed the patient from the ventilator, provided 100% oxygen via manual ventilation support which stabilized the patient, improving vital signs to baseline. During this time, the Nurse Manager heard a "Code Blue" called. He instructed that the "Code Blue" be cancelled. The Respiratory Therapist adjusted the ventilator. Following this incident, the physician voiced concern regarding the Respondent's ability to care for the patient. The Charge Nurse assumed care of the patient."
