Discussion ensued regarding the renewal requirements for APRN's who were grandfathered and do not have advanced practice certification.
- Motion** by D. Ford, seconded, that the Board adopt revised rules LAC46:XLVII.Chapter 45. Advanced Practice Registered Nurses, with editorial changes including the following amendment:  
Section 4507.E.2.a.: "A minimum of 300 hours of practice in advanced practice registered nurse, as defined in R.S.37:913.3.a, within a twelve (12) month period".
