### III. Purpose of the Articulation Focus Group

Dr. Booth stated that the charge of the group was to review articulation plans in nursing programs across the state and to establish a standardized articulation plan for nursing. She provided a history of the articulation model that was adopted by the Nursing Supply and Demand Commission (NSDC) in February 1993 in response to the charge mandated by Act 818 of the 1991 Louisiana Legislature. This Act established the NSDC and charged, in part, that an articulation model for nursing be established. This Focus Group was established at the request of the NSDC to go beyond the adopted model and specify an articulated plan. Dr. Booth, as Chair of the NSDC, requested that Barbara Morvant, Executive Director of the Louisiana State Board of Nursing (LSBN) assist in convening a focus group. The Board of the LSBN concurred in support of this initiative. The composition of the committee was chosen to represent the various levels of nursing education in Louisiana. A copy of a summary report that was submitted on November 22, 2004 to the Health Works Commission from the Education and Articulation Sub-Committee of the NSDC was distributed. A copy of the Articulation Model that was adopted in 1993 was provided.

Information was provided on articulation models/plans adopted by other states relative to numbers of hours that were awarded based on a variety of processes.

The group was charged with establishing a standardized number of hours to provided specificity to the Articulation Model, that could be awarded by various means for Certified Nursing Assistants (CNA) seeking to become Licensed Practical Nurses (LPN), LPN to associate

degree to become a Registered Nurse (RN) or LPN to RN and bachelors degree, and associate degree RN to bachelor's in nursing degree.

Support was expressed by the LSBN and the LSBPNE to promote and assist in the work of the Focus Group and to the initiative to standardize an articulation plan to promote articulation among Louisiana nursing programs at all levels.

#### IV. Discussion

Lengthy discussion ensued relative to the goals of the charge, the general expectations of all programs, the assumptions to guide development of a plan, the barriers to articulation, development of an actual plan, and recommendations. Dr. Booth will summarize the discussion in preparation for the meeting on December 15, 2004.

#### V. Recessed

The meeting was recessed at 2:40 pm and will reconvene at 9 am on December 15.

#### VI. Review of Draft of Plan

Dr. Booth provided as a draft of a plan prepared based on the discussion of the group on December 14<sup>th</sup>.

Following lengthy discussion, a plan was developed and agreed upon. (See attached) The plan will be brought to a meeting of the Louisiana Council of Administrators of Nursing Education, Inc. (LA CANE) in January to solicit their concurrence, and then to the NSDC. The goal is to have a final report prepared by early April, 2005.
