The next scheduled meeting is June 28, 2002 in Baton Rouge.

REPORT OF 2002 LOUISIANA LEGISLATIVE SPECIAL SESSION.

Ms. Morvant reported on the 2002 Louisiana Legislative Special Session. Board members received a report of the enrolled bills of interest to the Board.

Ms. Morvant stated that the Louisiana Health Works Commission was created and the bill did go into effect. The Louisiana Health Works Commission was modeled after the Nursing Supply and Demand Commission; however it is a broad base commission made up of

secretaries of state departments, legislators, nursing and allied health that might have some influence on how to actually affect any recommendations that would come out of the Commission that relate to providing a more qualified and adequate health care workforce for the state.

Nursing Supply and Demand Commission (NSDC) was left in tact with its charge and it will have a set on the Health Works Commission. The NSDC Chairperson will make recommendations to the Health Works Commission.

Ms. Morvant reported that as a result, a Health Works office has been established for this Commission and there is some minimum funding through the Governor's office for staff to this Health Works Commission.

The President of the Board is appointed to that Commission. There is a provision for an alternate should the president be unavailable to attend. Ms. McClanahan's name has been submitted for the Health Works Commission and the vice-president as an alternate.

A discussion then ensued.

REPORT OF 2002 LOUISIANA LEGISLATIVE REGULAR SESSION.
