New Business: Review and T. Elliott and C. Storm introduced a revised draft of the Evaluation Policy. The policy was reviewed with discussion focused on the use of polygraph testing as a diagnostic tool for

approval of the revised evaluation policy:

forensic psychologists. C. Storm researched this issue with other psychologists and the TX Board of Nursing (BON). The TX BON uses the polygraph examinations and forensic psychologist with some of their investigation cases. The Committee reviewed and discussed the objectivity of the polygraph examination, how much weight it will have in the decision making process once results have been received, and the number of nurses that may be referred. The Committee emphasized the importance of the polygraph being used as a tool to aid the psychologist in his report to the Board, and not as an independent report.

Review and approval

L.A.C.46:XLVII.3331

T. Elliott introduced the revised draft of LAC 45:XLVII.3331 Denial or Delay of Licensure, Reinstatement, or Right to Practice Nursing as a Student Nurse. The number of applicants applying for licensure and reinstatement with a prior serious criminal action has increased significantly. Since past behavior is often the best indicator of future behavior, the Board of Nursing has a duty to exclude individuals who pose a risk to public safety. Some professions/occupations in Louisiana and in other states prohibit felonies from engaging in practice. This revision will provide a permanent bar from nursing practice for serious felonies, and provide a time-limited bar for other serious crimes. The Committee reviewed the revisions, discussed and made corrections. It was recommended that the policy be revised to establish a timeframe for individuals that have been treated or diagnosed with alcoholism or chemical dependency and that the policy should state that individuals shall not be approved for licensure or nursing school until they have 5 years of sobriety and/or recovery. The committee also discussed the need for developing guidelines for identifying individuals who are at risk for other mental, emotional, or physical impairment, but no recommendations were finalized.
