William Carey University School of Nursing-Proposal for an Externship Nursing Elective:

Presentation of the specifics of the proposal by Dr. Cooksey.

The students would be paid to work as "CNAs" or "nurse techs" and would get college credit for it under a preceptorship type program.

Discussion ensued.

**Motion:** by Dr. Poirrier to accept the proposal for an externship elective as

presented by William Carey University School of Nursing

Seconded by Ms. MacMillan

Voice vote: Poirrier-yes; MacMillan-yes; Johnson-yes. Motion

carried.

Delgado Community College/ Charity School of Nursing- Request for approval of an RN Refresher Course:

(Dr. Steele-recused)

(Dr. Poirrier assumed chair)

Ms. Myers addressed the proposal stating that the course is divided into theory and clinical components, which addresses the needs of the nurse who either needs a number of hours to reinstate licensure or for

the nurse who may need to just obtain the knowledge and skills.

Discussion ensued at length.

An 80% passing standard was recommended as opposed to the 77% presented in the syllabus.

**Motion:** 

by Ms. MacMillan to approve the request by Delgado Community College for an RN Refresher course with an addendum that the grading criteria be reviewed along with the theory passing standard and the text.

Seconded by Ms. Johnson Motion carried.

**Nursing Shortage:** 

Dr. Poirrier suggested that the committee begin looking at reassessing the articulation model and to move forward with LPN Exit Option and look at developing a mentoring program to go along with it. Dr. Steele suggested that the committee's recommendations be added to the joint meetings between LSBN and LSBPNE agenda.

**Motion:** 

by Dr. Poirrier to recommend that the current sub-committee that is meeting to facilitate communication between the LPN Board and the LSBN Board bring this motion forward to examine the possibility of an LPN Exit Option for students currently enrolled in RN programs for discussion and approval.

Seconded by Ms. MacMillan

Voice vote: Poirrier-yes; MacMillan-yes; Johnson-yes. Motion carried.

The recommendation will be forwarded to the Board.

#### **Second recommendation:**

by Dr. Poirrier to recommend to enhance the articulation model by reducing the length of time it takes for an LPN to obtain an associate degree to become an RN (LPN to RN).

Discussion ensued.

A sub-committee task force will be established.

**Motion:** 

by Dr. Poirrier that the Board establish a task force to examine the accessibility of general education courses across Louisiana nursing

programs to promote faster completion for LPN to RN tracks.

Seconded by Ms. MacMillan

Voice vote: Poirrier-yes; Johnson -yes; MacMillan-yes; Motion

carried.

Discussion ensued.

Dr. Steele will defer the mentoring program component and highlight at the next committee meeting.

Old Business: Reports from Schools on Conditional Approval:

Dillard University-NCLEX-RN Results:

Staff stated that she has visited Dillard and at this point, they have 100% pass rate but eight students still have to take the NCLEX exam.

Action deferred until the next report.

Grambling State University-Site Visit Summary Report and NCLEX-RN Results:

Staff stated that she visited Grambling. Their NCLEX pass rate is currently 72.73%, which is their complete report.

Dr. Arhin gave a presentation on the problems and solutions of achieving the required 80% pass rate of the NCLEX exam.

Lengthy discussion ensued.

Action deferred until the report of the pass rates of the December 2007 graduates.

Southern University-Focused Report Site Visit Summary Report, and NCLEX-RN

Staff stated that a site visit was done at Southern and that all graduates have taken the NCLEX exam with a pass rate of 84.1%.

**Results:** Southern is requesting to have full approval status restored.

**Motion:** by Dr. Poirrier that Southern University be removed from conditional

approval status to that of full approval status by the Board.

**Implementation of Criminal Background Checks for Students:** 

Chairman deferred item until the next committee meeting; as there are no changes that need to be recommended at this time.

Louisiana State **University at Eunice** Request for a Pilot Study on the Use of **Preceptors:**

Information on the proposal presented by Ms. Johnson. The pilot program is requested for the Spring of 2008.

A lengthy discussion ensued.

**Motion:** 

by Ms. MacMillan to accept the proposed preceptor pilot project at LSU-Eunice for a one semester time frame and that exceptions for the

Board rule for the pilot project be approved as revised.

Revision to #2, page 2 of the project booklet to read as follows: Allow the preceptor to be an ADN graduate with at least five years of practice experience and at least one year on the current unit.

Voice vote: Dr. Poirrier -yes; Ms. MacMillan -yes. Motion carried.

**Site Visit Summary Report-Fletcher Technical Community College Proposal to Initiate an Associate Degree in Nursing Program:** 

Staff made a site visit to the school. It was reported that Fletcher has begun to screen applicants. Nursing courses will begin in January

2008.

**Motion:** 

by Dr. Poirrier to grant initial approval to Fletcher Technical Community College for the Associate of Science in Nursing Program and approve admission of students for January 2008 with the following recommendation and one suggestion:

### Recommend:

1. That Fletcher Technical Community College acquire onsite secretarial support staff for the Division of Nursing and Allied Health.

### Suggestions:

1. That Fletcher Technical Community College acquire a skills laboratory coordinator in the near future.

Seconded by Ms. Johnson Voice vote: Dr. Poirrier –yes; Ms. Johnson –yes; Ms. MacMillan – yes. Motion carried.

Update on Revision of the LSBN School Annual Report Form:

Chairman stated there was a sub-committee that reviewed the annual report form and made recommendations and suggestions. Some revisions to be recommended to the Board will be to change the reporting period from October to October to July 1<sup>st</sup> to June 30<sup>th</sup>. Another revision made was in regard to reporting numbers related to the accelerated programs making the data more specific so that they could be tracked. Also the pages of the report that describe the course and clinical agencies were deleted. The revised form will be presented to the Board in March 2008.

by Dr. Poirrier to present the report to LACANE and circulate to schools of nursing across the state for additional comment.
