New Business

Report on APRN Roundtable

Committee co-chair (L. Agosta) stated she attended the NCSBN APRN Roundtable meeting held on May 19, 2010 and reported the following:

- LSBN is further ahead than most States in pursuing the initiative regarding the NCSBN Consensus Document.
- Approximately eight (8) States have established Task Forces.
- Hawaii has already passed legislation following the Consensus Document recommendations.
- Report by the J. Macy foundation entitled 'Who Will Provide Primary Care
 and How Will They Be Trained' was discussed and is supportive of the
 initiative for APRNs.
- Another report was reviewed which explained that all healthcare providers had a legally defined 'scope of practice' except physicians who tend to develop skills as necessary. The report stated that the AMA considers 'collaboration' as equaling supervision which is in contrast to the position that collaboration is a dynamic and overlapping function performed by all healthcare providers as a norm of regular practice.
- That APRN education programs in the 3 P's (Advanced Physical Health Assessment, Advanced Pharmacology, and Advanced Pathophysiology) not be limited to a specific population focus (such as pediatric or adult), but across patient lifespan.
- The following suggestions were offered for State BONs to consider during their planning for effecting changes toward the NCSBN Consensus Model for APRNs:
 - Have a consistent message.
 - Do not further confuse the consumer. The definition of a 'nurse' is already somewhat confusing to the public. BONs are still working on nursing education needed to prepare a registered nurse. They stressed that BONs should be on the same page.
 - Develop a 'White Paper' that is simple and short with bullet points.

- In providing information to the public, the 'White Paper' should be provided as the official BON response and avoid providing individual interpretations.
- Know the opposition. In developing a position on the Consensus Model initiative, it's unavoidable that some opposition will arise. They stressed that progress will be incremental and on some issues many take several years to accomplish.
- Develop a grass roots effort to support the BONs initiatives. This may take several years and involve the support and participation of many of our nursing organizations and other healthcare organizations.
- AARP is in support of APRN education and could provide assistance to the grass roots effort to support the initiative.

Co-chairs (L. Agosta and D. Porche) plan to meet with the Ex-officio Board Members (W. LaCorte and R. Bass) who are both licensed physicians and discuss the issues related to the APRN Consensus Model and on-going Task Force for feedback.

Co-chair (L. Agosta) stated that APRNs with collaborating physicians feel they have the support of their physicians regarding making changes to Chapter 45 to do away with the current prescriptive authority application process and that they also consider the paperwork tedious. Co-chairs are planning on working with the Nursing Research Center to develop a survey for collaborating physicians so that feedback can be obtained from them directly. Once the data from the survey has been collected, co-chairs plan to have various meetings and/or discussions with representatives from several sectors/organizations to review the survey findings and proposed APRN changes, such as:

- Louisiana State Board of Medical Examiners
- Louisiana Medical Society
- Legislative sponsors and lobbyists
- Non-nursing organizations/groups such as: LAMMICO, Louisiana Nursing Home Association, Podiatrists organization, AARP, etc that could offer support to the grass roots effort of the initiative.

Teleconference with NCSBN

A teleconference was held at the Louisiana State Board of Nursing office with NCSBN representative (Nancy Chornick) to review the comparison of the APRN Consensus Model to the Louisiana Nurse Practice Act (NPA) and Chapter 45 of the Rules and Regulations for LSBN. A summary of the recommendations of the NCSBN representative (N. Chornick) during the teleconference was distributed. Some of the recommendations would require a change of statutes and/or rules and regulations, including:

- Remove specialty APRN licensure (such as oncology) and limit APRN licensures to one of the four (4) AP roles and population focus.
- Remove non-certified mechanisms for licensure, such as commensurate requirements.
- Eliminate temporary permits for initial AP licensure.
- Eliminate the 6 CE hours of pharmacology requirement for annual renewal.
- Educational programs for advance practice would be approved by appropriate accreditation body instead of the Board and require pre-approval before acceptance of students.
- Independent and non-supervised collaborative practice.

Update of NCSBN Comparison Chart

Chart showing NCSBN Model Rules and a comparison to current LSBN Nurse Practice Act (NPA) and Chapter 45 rules and regulations is available for viewing by committee members at Sharepoint. A decision is pending on how each committee member's recommendation to either NPA and/or Chapter 45 will be recorded. To avoid duplicity, it was suggested at a prior meeting that committee members would route their recommendations to the task force co-chairs who would consolidate feedback and have an updated chart posted to the Sharepoint site for committee members to review of further suggestions.

Next Meeting

The Task Force meeting tentatively scheduled for July 16, 2010 was cancelled. Cochairs will be working to consolidate the various research documentation obtained by the members in order to start preparing drafts. Committee members will be contacted when another meeting is scheduled in the future.
