## Respondent shall:

Within thirty (30) days, submit to a forensic outpatient evaluation at Respondent's expense with either Thomas Carl Fain, PhD (225-387-3325) or Brandon P. Romano, Psy. D., M.S.C.P., (225-769-2533), which Evaluation shall include an anger management evaluation and/or other testing deemed appropriate by the qualified evaluator based on Respondent's history. Respondent shall further authorize and cause a written report of the Evaluation to be submitted to the Board. The Evaluation report shall include diagnosis, course of treatment, prescribed and/or recommended treatment, prognosis, and/or professional opinion as to Respondent's capability of practicing nursing with reasonable skill and safety to patients.

Submit all pages of this Findings of Fact, Conclusions of Law, and Order to each qualified evaluator prior to the start of the Evaluation for the Evaluation to be deemed valid.

Immediately submit to all recommendation(s) of the qualified evaluator and provide evidence of continued compliance with all recommendation(s) made by the qualified evaluator. Respondent shall meet with the Board or Board staff if the Evaluation results in any treatment, recommendation(s), or finding that warrants concern for patient safety. In any such event, Respondent shall demonstrate to the reasonable satisfaction of the Board that Respondent poses no danger either to the practice of nursing or the public and that Respondent is able to safely and competently perform the duties of a registered nurse.

Prior to beginning or returning to work, inform all nursing employers of these disciplinary measures and of the probationary status of license. Respondent is responsible to submit a copy of all pages of this Findings of Fact, Conclusions of Law, and Order to each employer and nursing supervisor.

Prior to beginning or returning to work, cause all employers to submit to the Board a signed Employer's Agreement from each employer.

Have all immediate nursing supervisors submit a performance evaluation report quarterly, commencing from the first date of employment. Quarterly reports are due on or before the first day of January, April, July, and October.

Work in a restrictive environment as a member of a treatment team rather than alone or with a few employees. Additionally, not be employed in any unsupervised setting. Must be directly supervised by an onsite registered nurse or other healthcare professional that is higher on the organizational chart than Respondent. Not be employed in agency/pool/staffing, home health services, or nursing homes.

Immediately (within 72 hours) inform the Board in writing of any change in address.

Immediately inform the Board in writing of all places of employment. If employment changes, the Board shall be immediately (within 72 hours) notified in writing.

If unemployed, inform the Board in writing on a quarterly basis.

Shall engage in the practice of professional nursing in Louisiana for a minimum of twenty-four (24) hours per week for a minimum twelve (12) consecutive months.

On or before Friday, January 20, 2023, submit payment of \$1,000.00 to the Board as a fine.

On or before Friday, January 20, 2023, submit payment of \$600.00 to the Board as cost of this hearing.

By the first of each month, submit a monthly probation fee of twenty-five dollars (\$25.00) to the Board, beginning September 1, 2022.

Not have any further misconduct, criminal violations or convictions, or violations of any health care regulations reported to the Board related to this or any other incidents.

Failure to comply with the above orders, receipt of an unfavorable report, or non-receipt of reports on or before the date due shall result in the immediate suspension of Respondent's license. This suspension can be imposed by action of the Executive Director subject to the discretionary review of the Board.

Reporting: This will be reported to the National Practitioner Data Bank (NPDB) as 14: Patient Abuse and F7: Substandard or Inadequate Skill Level.

NPDB: Narrative: By Final Order, Respondent's Registered Nurse license is suspended with stay and probated for two (2) years with stipulations after Respondent failed to use proper CPI de-escalation techniques and engaged in a physical altercation with a person.
